WAIVER AGREEMENT

LIABILITY WAIVER:

I, the undersigned, agree that if you participate in or attend any D1 BULLPENS training sessions or related events, or are present on Newtown Edgemont Little League Complex or use another D1 Bullpens sanctioned facility, you do so at your own risk and assume the risk of any or all injury and/or damage you might sustain, regardless of whether you are a participant, a spectator, or otherwise. You agree that you are voluntarily participating in the aforementioned activities and assume all risk, known and unknown, associated with same. You agree on behalf of yourself (and your spouse, all your children, personal representatives, heirs, executors, administrators, agents, and assigns) to forever release and discharge D1 BULLPENS, their owner, employees and representatives and assigns from any and all claims or causes of action (known or unknown) arising out of negligence of D1 BULLPENS, whether active or passive, or that of any of its affiliates, employees, representatives. This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your use of any equipment or facilities which may malfunction or break, (b) D1 Bullpens or Newtown Edgemont Little Leagues improper maintenance of core velocity equipment or facilities, (c) D1 BULLPENS negligent instruction or supervision, including personal training and coaching, (d) you slipping or tripping and falling while on Newtown Edgemont Little League Complex or any other D1 Bullpens sanctioned facility premises, including negligent inspection or maintenance of such premises by Newtown Edgemont or D1 Bullpens. By executing this Agreement, you hereby agree to indemnify and hold harmless D1 Bullpens, Newtown Edgemont Little League and all D1 Bullpen sanctioned facilities from any loss, liability, damage, or cost these parties may incur due to your presence at any D1 Bullpens sanctioned facilities. You further expressly agree that the forgoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by law of the state in which the agreement is entered into, and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
